# 1. Opening of Meeting:

Cllr Priestley (Chair) welcomed everyone to the meeting

# 2. Apologies:

# 3. Declarations of Interest:

#### 4. Minutes of previous meeting:

Minutes of the previous meeting held on the 7<sup>th</sup> July 2022 were read and verified by Cllr Priestley (Chair).

#### 7. Expenditure/Budget Review/Bank Reconciliation: - noted

Councillors reviewed the budget vs spend report for 2022-2023 and agreed it is running in line with the budget agreed.

# 8. NatWest:

It was proposed to transfer monies from the Current Account to the Deposit Account, the amount to transfer will be set at the Budget Proposal in November.

# 9. Grant Applications:

The council had two applications for grants to be considered one from Severnside Nuclear Youth FC and one from Dursley and Good Neighbours. It was agreed to grant Dursley and Good Neighbours £250.00. The council agreed they would review the grant from Severnside Nuclear Youth FC later in the year.

The council agreed to adopt the LOGO designed for the Hamfallow Parish website and apply it to all parish documentation and assets.

# 15. Noticeboard Project:

The council agreed to do a Noticeboard report before the next meeting in November before a decision was made to which way to move forward with the notice boards. Cllr King kindly agreed to visit each noticeboard and do a report on each one and report back to council with his findings.

# 16. <u>Risk Assessment:</u>

On advice from the Internal Auditor the present Risk Assessment needed to be reviewed and recommendations made by the by Internal Auditor needed to be implemented. Cllr King agreed to review the current Risk Assessment and implement the recommendations from the Internal Auditor.

# 17. Grass Cutting:

The council agreed with the cost of living rising considerably they would give the grass cutting contractor a one of payment to help with rising fuel costs. The amount to be confirmed at the November meeting.
